THE VESSEL CARRIED OUT A PROCEDURE FOR CAUSTIC WASHING ON SEVERAL CARGOES AND NEEDED TO DISCHARGE A RELATIVELY SMALL AMOUNT OF RESIDUAL WASTE ('SLOPS'). IN OR AROUND AUGUST 2006, THE "PROBO KOALA" WAS SCHEDULED TO CALL AT THE PORT OF AMSTERDAM FOR THE PURPOSES OF DISCHARGING PETROLEUM SLOPS WHICH HAD BEEN PRODUCED ONBOARD THE VESSEL DURING THE TREATMENT OF COKING NAPHTHA. A LOCAL COMPANY HAD BEEN CONTRACTED TO PROVIDE SERVICES REGARDING THE HANDLING AND DISPOSAL OF THESE SLOPS. HOWEVER, THERE WAS A DISAGREEMENT AND AFTER SOME OF THE SLOPS HAD BEEN UNLOADED, IT WAS DECIDED THAT THE COMPANY WOULD NOT PERFORM THE SERVICES. TRAFIGURA WAS CHARGED IN THE NETHERLANDS REGARDING 1 THE WRONGFUL EXPORT OF WASTE FROM THE EU (FIRST COUNT); 2. THE MISDESCRIPTION OF THAT WASTE (SECOND COUNT) AND 3. THE FORGERY OF DOCUMENTS RELATING TO THAT WASTE (THIRD COUNT). TRAFIGURA WAS CONVICTED ON THE FIRST AND SECOND COUNTS. THESE CONVICTIONS WERE CONFIRMED BY THE DUTCH COURT OF APPEAL ON 23RD DECEMBER, 2011. TRAFIGURA WAS ACQUITTED ON THE THIRD COUNT WHICH WAS ALSO CONFIRMED BY THE DUTCH COURT OF APPEAL ON 23RD DECEMBER, 2011. ON 16TH NOVEMBER, 2012 TRAFIGURA CONCLUDED A COMPREHENSIVE SETTLEMENT WITH THE DUTCH AUTHORITIES REGARDING THE INCIDENT (THE "SETTLEMENT").
